1. APOLOGIES.

- 1. The matter not being a local issue, it need not necessarily be discussed by the Parish Council, and
- 2. District Council will conduct the Poll, but the costs (in the region of £1,000.00 and £1,500.00), will have to be met by the Parish Council. However, it is possible The Campaign Alliance for Referendums in Parishes may pay the costs, but there is no guarantee. Regarding the Application for the Land adjacent to 9 Mountjoy: Again, I have been in touch with both your Clerk and the District Council.

I can now confirm that the Application has been Refused on the ground that the proposed development would be detrimental to the character and appearance of the locality.
